#### 1. Aims

Our school aims to meet its statutory obligations when responding to complaints from parents of pupils at the school.

When responding to complaints, we aim to:

- > Be impartial and non-adversarial
- > Facilitate a full and fair investigation by an independent person or panel, where necessary
- > Address all the points at issue and provide an effective and prompt response
- > Respect complainants' desire for confidentiality
- > Treat complainants with respect and courtesy
- > Make sure that any decisions we make are lawful, rational, reasonable, fair and proportionate, in line with the principles of administrative law
- > Keep complainants informed of the progress of the complaints process
- > Consider how the complaint can feed into school improvement evaluation processes

We try to resolve concerns or complaints by informal means wherever possible. Where this is not possible, formal procedures will be followed.

The school will aim to give the complainant the opportunity to complete the complaints procedure in full.

To support this, we will make sure we publicise the existence of this policy and make it available on the school website.

Throughout the process, we will be sensitive to the needs of all parties involved, and make any reasonable adjustments needed to accommodate individuals.

# 2. Legislation and guidance

This document meets the requirements set out in part 7 of the schedule to the Education (Independent School Standards) Regulations 2014, which states that we must have and make available a written procedure to deal with complaints from parents of pupils at the school.

It is also based on guidance published by the Education and Skills Funding Agency (ESFA) on <u>creating a complaints procedure that complies with the above regulations</u>, and refers to <u>good practice guidance on setting up complaints procedures</u> from the Department for Education (DfE).

In addition, it addresses duties set out in the <u>Early Years Foundation Stage statutory framework</u> with regards to dealing with complaints about the school's fulfilment of Early Years Foundation Stage requirements.

## 3. Purpose

St Martin's School intends to resolve complaints informally where possible, at the earliest possible stage.

There may be occasions when complainants would like to raise their concerns formally. This policy outlines the procedure relating to handling such complaints.

Complaints about services provided by other providers who use school premises or facilities should be directed to the provider concerned.

## 4. Roles and responsibilities

#### 4.1 The complainant

The complainant will get a more effective and timely response to their complaint if they:

- > Follow these procedures
- > Co-operate with the school throughout the process, and respond to deadlines and communication promptly
- > Ask for assistance as needed
- > Treat all those involved with respect
- > Do not publish details about the complaint on social media or other communication platforms

## 4.2 The investigator

An individual will be appointed to look into the complaint and establish the facts. They will:

- > Interview all relevant parties, keeping notes
- > Consider records and any written evidence and keep these securely
- > Prepare a comprehensive report, which includes the facts and potential solutions

#### 4.3 The complaints co-ordinator

The complaints co-ordinator can be:

- > A member of SLT/a member of administrative staff
- > The proprietor

The complaints co-ordinator will:

- > Keep the complainant up to date at each stage in the procedure
- > Make sure the process runs smoothly by liaising with staff members and the headteacher.
- > Be aware of issues relating to:
  - Sharing third party information
  - Additional support needed by complainants, for example interpretation support or where the complainant is a child or young person
- > Keep records
- > Be the contact point for the complainant and the complaints committee, including circulating the relevant papers and evidence before complaints committee meetings
- > Arrange the complaints hearing

- > Record and circulate the minutes and outcome of the hearing
- > Chair the meeting, ensuring that everyone is treated with respect throughout
- > Make sure all parties see the relevant information, understand the purpose of the committee, and are allowed to present their case

## 5. Principles for investigation

When investigating a complaint, we will try to clarify:

- > What has happened
- > Who was involved
- > What the complainant feels would put things right

#### 5.1 Time scales

The complainant must raise the complaint within 3 months of the incident. If the complaint is about a series of related incidents, they must raise the complaint within 3 months of the last incident.

We will consider exceptions to this timeframe in circumstances where there were valid reasons for not making a complaint at that time and the complaint can still be investigated in a fair manner for all involved.

When complaints are made out of term time, we will consider them to have been received on the first school day after the holiday period.

If at any point we cannot meet the timescales we have set out in this policy, we will:

- > Set new time limits with the complainant
- > Send the complainant details of the new deadline and explain the delay

### 5.2 Complaints about our fulfilment of early years requirements

We will investigate all written complaints relating to the school's fulfilment of the Early Years Foundation Stage requirements, and notify the complainant of the outcome within 28 days of receiving the complaint. The school will keep a record of the complaint (see section 10) and make this available to Ofsted on request.

Parents and carers can notify Ofsted if they believe that the school is not meeting Early Years Foundation Stage requirements, by calling 0300 123 4666, or by emailing <a href="mailto:enquiries@ofsted.gov.uk">enquiries@ofsted.gov.uk</a>. We will notify parents and carers if we become aware that the school is to be inspected. We will also supply a copy of the inspection report to parents and carers of children attending the setting on a regular basis.

# 6. Stages of complaint (not complaints against the headteacher)

#### 6.1 Stage 1: informal

The school will take informal concerns seriously and make every effort to resolve the matter quickly. It may be the case that the provision or clarification of information will resolve the issue.

The complainant should raise the complaint as soon as possible with the relevant member of staff or the headteacher as appropriate, either in person or by letter, telephone or email. If the complainant is unclear who to contact or how to contact them, they should contact the school office on <a href="mailto:admin@stmartinsschool.net">admin@stmartinsschool.net</a> or by calling 01202 292011.

The school will typically acknowledge informal complaints within 3 school days and investigate and provide a response normally within 5 school days.

The informal stage will involve a meeting between the complainant and the relevant member of staff or the headteacher, as appropriate.

If the complaint is not resolved informally, it will be escalated to a formal complaint.

#### 6.2 Stage 2: formal

Formal complaints can be raised:

> By letter or email (this can be by a third party acting on behalf of the complainant, if necessary)

The complainant should provide details such as relevant dates, times, and the names of witnesses of events, alongside copies of any relevant documents, and what they feel would resolve the complaint.

The headteacher will record the date the complaint is received and will normally acknowledge receipt of the complaint in writing (either by letter or email) within 3 school days.

The headteacher (or designated member of the senior leadership team) will call a meeting to clarify concerns and seek a resolution. The complainant may be accompanied to this meeting and should inform the school of the identity of their companion in advance.

In certain circumstances, the school may need to refuse a request for a particular individual to attend any such meeting – for example, if there is a conflict of interest. If this is the case, the school will notify the complainant as soon as they are aware, so that the complainant has the opportunity to arrange alternative accompaniment.

The headteacher (or other person appointed by the headteacher for this purpose) will then conduct their own investigation. The written conclusion of this investigation will be sent to the complainant typically within 10 school days.

If the complainant wishes to proceed to the next stage of the procedure, they should inform the proprietor in writing within 5 school days of receiving the written conclusion.

#### 6.3 Stage 3: review panel

#### Convening the panel

Complaints will be escalated to the panel hearing stage if the complainant is not satisfied with the response to the complaint at the second, formal, stage.

The panel will be appointed by or on behalf of the proprietor and must consist of at least 3 people who were not directly involved in the matters detailed in the complaint. At least 1 panel member must be independent of the management and running of the school.

The panel will have access to the existing record of the complaint's progress (see section 10).

The complainant must have reasonable notice of the date of the review panel. The proprietor will aim to find a suitable date within 10 school days of the request, where possible.

If the complainant rejects the offer of 3 proposed dates without good reason, the proprietor will set a date. The hearing will go ahead using written submissions from both parties.

Any written material will be circulated to all parties at least 5 school days before the date of the meeting.

#### At the meeting

The meeting will be held in private. Electronic recordings of meetings or conversations are not normally permitted unless a complainant's own disability or special needs require it (prior knowledge and consent of all parties attending will be sought and minuted before meetings or conversations take place.)

At the review panel meeting, the complainant and representatives from the school, as appropriate, will be present. Each will have an opportunity to set out written or oral submissions prior to the meeting.

The complainant must be allowed to attend the panel hearing and be accompanied if they wish. We don't encourage either party to bring legal representation, but will consider it on a case-by-case basis. For instance, if a school employee is called as a witness in a complaint meeting, they may wish to be supported by their union.

Representatives from the media are not permitted to attend.

At the meeting, each individual will have the opportunity to give statements and present their evidence, and witnesses will be called, as appropriate, to present their evidence.

The panel, the complainant and the school representative(s) will be given the chance to ask and reply to questions. Once the complainant and school representative(s) have presented their cases, they will be asked to leave and evidence will then be considered.

The panel will then put together its findings and recommendations from the case. The panel will also provide copies of the minutes of the hearing and the findings and recommendations to the complainant and, where relevant, the individual who is the subject of the complaint, and make a copy available for inspection by the proprietor and headteacher.

#### The outcome

The committee can:

- > Uphold the complaint, in whole or in part
- > Dismiss the complaint, in whole or in part

If the complaint is upheld, the committee will:

- > Decide the appropriate action to resolve the complaint
- > Where appropriate, recommend changes to the school's systems or procedures to prevent similar issues in the future

The school will inform those involved of the decision in writing within 10 school days.

## 7. Complaints against the headteacher

#### 7.1 Formal

Complaints made against the headteacher should be directed to proprietor in the first instance. The steps in stage 2 (set out in section 6 above) will be carried out by the proprietor, who will write a formal response at the end of their investigation.

#### 7.2 Review panel

If the complaint reaches the review panel stage, the proprietors will coordinate and carry out the steps at stage 3 (set out in section 6 above).

# 8. Referring complaints on completion of the school's procedure

If the complainant is unsatisfied with the outcome of the school's complaints procedure and the complaint is regarding the school not meeting standards set by the DfE in any of the following areas, the complainant can refer their complaint to the DfE:

- > Education
- > Pupil welfare and health and safety
- > School premises
- > Staff suitability
- > Making information available to parents
- > The spiritual, moral, social or cultural development of pupils

The DfE will consider reports of a major failure to meet the standards. Where appropriate, it can arrange an emergency inspection to look at pupil welfare and health and safety, and make sure that the school deals with serious failings.

## 9. Record keeping

The school will record the progress of all complaints, including information about actions taken at all stages, the stage at which the complaint was resolved, and the final outcome. The records will also include copies of letters and emails, and notes relating to meetings and phone calls.

This material will be treated as confidential and held centrally, and will be viewed only by those involved in investigating the complaint or on the review panel.

This is except where the secretary of state (or someone acting on their behalf) or the complainant requests access to records of a complaint through a freedom of information (FOI) request or through a subject access request under the terms of the Data Protection Act, or where the material must be made available during a school inspection.

Records of complaints will be kept securely, only for as long as necessary and in line with data protection law, our privacy notices.

#### 10. Reflection

The proprietor will review any underlying issues raised by complaints with the headteacher, where appropriate, and respecting confidentiality, to determine whether there are any improvements that the school can make to its procedures or practice to help prevent similar events in the future.

## 11. Monitoring arrangements

The proprietor will monitor the effectiveness of the complaints procedure in making sure that complaints are handled properly. The headteacher will track the number and nature of complaints, and review underlying issues as stated in section 11.

The complaints records are logged and managed by the headteacher.

This policy will be reviewed by the headteacher annually.

At each review, the policy will be approved by the proprietor.
